Subject: Policy of not Accepting All Kinds of Presents and Gifts
from Performing Duties (No Gift Policy)
Fiscal Year B.E. 2567 (A.D. 2024)

The President, as the Chief Executive of Kanchanaburi Rajabhat University, recognizes the importance of creating transparency within the organization, building attitudes and values in performing duties to raise awareness, create a culture of integrity and service mindfulness to those who utilize services with fairness through the standard operations of Kanchanaburi Rajabhat University. In addition, the reform activities 4 (Developing the Thai bureaucracy to be transparent and benefit-free, Goal 1, Clause 1.1) under the implementation of the major reform activities (Big Rock) has been driven for all government agencies to declare that their officials refrain from accepting all kinds of presents and gifts from performing duties (No Gift Policy).

Kanchanaburi Rajabhat University is committed to opposing all forms of corruption and misconduct while striving to enhance morality, ethics, and honesty in the execution of duties. This drive for transparency within personnel operations aligns with the principles of Good Governance. Kanchanaburi Rajabhat University would like to implement the Policy of Not Accepting All Kinds of Presents and Gifts from Performing Duties (No Gift Policy). It is a government agency where government officials do not accept all kinds of presents and gifts from performing duties. The administrators and personnel of Kanchanaburi Rajabhat University strictly adhere to the following practices:


1. The executives and personnel of Kanchanaburi Rajabhat University refrain from accepting all kinds of presents and gifts from visitors, before, during, and after performing duties on all festivals or any other occasions.
2. The executives and personnel of Kanchanaburi Rajabhat University refrain from giving all presents and gifts to visitors.
3. The executives and personnel of Kanchanaburi Rajabhat University must not seek any unlawful presents, gifts, or benefits.
4. It is preferable to express felicitation, best wishes, welcoming, or condolences as usual by signing greeting cards and books or greeting through social media instead of giving things.

5. In cases where it is necessary to give or accept property or any other benefits according to morality or tradition, all must comply with the Regulations of the Office of the Prime Minister regarding Giving or Receiving Gifts of Government Officials B.E. 2565 (2022) and the Announcement of the National Anti-Corruption Commission on the criteria of Giving or Accepting property or any other benefits according to the morality of Government Officials B.E. 2563 (2020).

6. The executives and personnel of Kanchanaburi Rajabhat University are responsible for keeping outsiders fully informed of this policy.
